ASSUMPTION OF RISK: I recognize and understand the risks associated with participating in the BMO Vancouver Marathon, Half Marathon, 8K, Friendship Run, Kids MaraFun or any other marathon event (collectively, "Events") may include risks that could be hazardous to me, and may put me at risk of serious injury or illness, including death.

WAIVER AND RELEASE: To the fullest extent permitted by law, I hereby forever release, waive, covenant not to sue, exonerate, discharge and agree to hold harmless the Released Parties from any and all liability, claims, demands, and causes of action whatsoever that I may have against the Released Parties with respect to any injury, illness, death, property damage or other loss that may result, directly or indirectly, from my participation in any of the Events.

MEDICAL TREATMENT: If I am unable to consent at the time due to injury or illness, I hereby consent to the administration of first aid and other emergency medical treatment for such injury or illness that occurs during any of my participation in the Events.
